**Refund & Cancellation Terms for the bookings made during UGADI HOLIDAY MELA 2025**

**International & Domestic Holiday Packages**

The customer has an option to amend the booking from domestic to International and vice versa as below without any cancellation charges.

1. **For the journey dates from April to July: within 10 days** from the date of booking in case of **non- flight included packages**
2. **For the journey dates from April to July: within 5 days** from the date of booking in case of **flight included packages**

As March, April, May & June are peak season months, you are suggested to pay the full advance amount at the time of booking to protect the fare quoted to you [published fare +supplement charge(if any)]. In case full advance amount is not paid at the time of booking, additional surcharge may apply.

3. **For the journey dates from August: within 10 days** from the date of **booking for all packages (both flight & non-flight included)**

- The initial deposit amount is non-refundable.
- In case of UK VISA, rejection by the concerned authorities a nominal amount of Rs. 50,000 is charged against incidentals / service fees. Plus flight ticket cancellation amount + Visa fees + land package (if any), will be deducted out of your advance.
- In cases where flight, helicopter, train, visa, travel insurance, safari tours, and cruise are included, the actual cancellation of the service provider will be charged
- The initial amount can be utilised against Southern Travels holiday packages only. [It cannot be used against standalone services such as flight, helicopter, train, safari tours, & cruise].
- In case of lockdown decided by Govt. of India, the customer can avail full refund as per the “cancellation charges for package tours” mentioned in Domestic & International brochures. However, the company will try its best to refund the amount paid by the customer after deducting the actual amount incurred on services such as flight, helicopter, train, safari tours, visa, travel insurance, cruise, hotels, transportation, meals and any other services along with a nominal service charge of Rs. 5000/- the balance amount will be refunded. In case the refund is not taken and balance amount is utilized in booking Southern Travels holiday packages, then the above service charge of Rs. 5000/- will not be deducted.
